1. Evidence of ownership (Bill of Sale, etc.) affidavits if applicable.
2. Registration Fee of \$5.00.
3. Certificate of Airworthiness Fee of \$5.00.
4. Weight and Balance Report (in duplicate).
5. Airplane Flight Manual.
6. Certificate of Airworthiness for export or equivalent document.
7. Operating limitations.
8. Customs clearance Form B.1.
9. Certification of Aircraft imported complete Form No. 2443.
