Mr. Barry moved, that the House do come to a Resolution as follows, viz:

A Petition of William Taylor, was presented by Mr. J. E. Morton, and read, praying compensation for losses sustained in procuring Packets to carry the Mail between Digby and St John, New-Brunswick, and in being deprived of the carriage thereof.

A Petition of Samuel Morehouse, was presented by Mr. J. E. Morton, and read, praying an increase of Allowance as Post-rider, between Digby and Long, and Breyar's Islands.

A Petition of Thomas Smalle, was presented by Mr. J. E. Morton, and read, praying reimbursement of Monies over expended by him, as Commissioner on the Racket Bridge in Digby.

A Petition of the Overseers of the Poor for the Township of Digby, was presented by Mr. J. E. Morton, and read, praying re-payment of Monies advanced by them, for the relief of certain transient ship wrecked Seamen.

A Petition of Samuel Canady, and others, was presented by Mr. J. Morton, and read, praying further aid in the erection of a Pier or Wharf at Black Rock, in Cornwallis.

A Petition of James Allison, and others, was presented by Mr. J. Morton, and read, praying further aid towards completing an embankment against the encroachment of the Tide, at the Townplot in Cornwallis.

A Petition of Hugh McDonald, was presented by Mr. R. Smith, and read, praying a bounty for the erection of an Oat Mill, in Douglas.

A Petition of the Rev. J. M. Segoyne, was presented by Mr. Haliburton, and read, praying a grant of Monies towards the education of poor Children, in Clare.

A Petition of Smith R. Harding, was presented by Mr. Forman, and read, praying relief from imprisonment in Yarmouth, for debt, at the suit of the Crown.

A Petition of the Overseers of the Poor, for the Township of Yarmouth, was presented by Mr. Poole, and read, praying relief from expenses by them incurred, in the support and medical aid of a transient Pauper.
