

THE PUBLIC LIBRARY BOARD.

Hon. T. W. Anglin and Messrs. W. Mars, F. Somers, K. P. Pearson, John Taylor and A. R. Rowell were the members of the Public Library Board at attendance at the meeting yesterday. The business was conducted with their usual despatch.

Contractor Davies was granted \$100 for extra in connection with the improvement lately effected in the building.

The Library Committee reported the receipt of a letter from the Hamilton Library Board asking co-operation in an attempt to secure legislation that would make a janitor of a free library a constable and empower him to arrest persons injuring library property. The Toronto Board considered the proposition favorably. The committee had bought 132 new books at a cost of \$273.
