The Institute produces several different types of publications, each filling a particular need.

OCCASIONAL PAPERS

These monographs aim for scholarly excellence and policy relevance.

BACKGROUND PAPERS

Written in a non-academic style. Provide timely analysis of major events and emerging issues.

WORKING PAPERS

Designed for rapid distribution. Summarize the results of research work-in-progress or the proceedings of conferences.

FACTSHEETS

Intended mainly for secondary schools. Provide short synopses of current issues and their historical contexts.

THE GUIDE

An annual sourcebook on Canada's peace and security policies. Presents background information, along with government and Parliamentary comment, on major issues.

DIRECTOR'S ANNUAL STATEMENT

Takes stock of the year's major events and trends in peace and security, and explores their implications for Canadian policy.

ANNUAL REPORT

Sets out for the Parliament and the people of Canada the record of Institute activities and financial statements for each fiscal year.

BIBLIOGRAPHIC REFERENCE WORKS

These bibliographies and other items make peace and security titles and subjects more easily accessible to the researcher.

PEACE & SECURITY

A quarterly magazine providing a forum for a wide range of Canadian and international analyses and viewpoints.

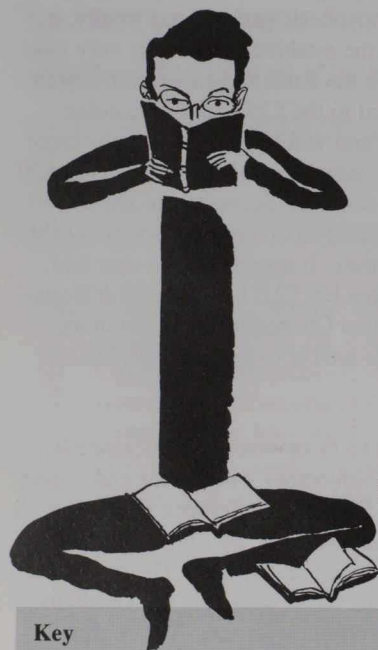
