Resolution,—To extend period of loans to 30 years; increase ratio of loan; authorize Central Mortgage and Housing Corporation to guarantee expenditure of insurance companies, etc., *re* land development for housing, etc.; House to go into Committee on, 324. Motion that Mr. Speaker do now leave the Chair, moved and agreed to, after debate, 365. Resolution adopted, 365. Bill No. 176 (Mr. Howe)—An Act to amend the National Housing Act, 1944; 1st R., 366. 2nd R., 465 (after debate). Reported from Committee of the Whole without amendment, 465. 3rd R., 465.
