And the question being put on the main motion, it was agreed to, on division.

The said Bill was accordingly read the second time, on division, and referred to the *Standing Committee on Miscellaneous Private Bills* (together with the evidence taken and the papers produced in respect of the said Bill).

The Order being read for the second reading of Bill No. 230 (Letter C-8 of the Senate), intituled: "An Act for the relief of Joseph Ricardo Bouziane";

Mr. Henderson, seconded by Mr. James, moved,—That the said Bill be now read the second time.

And a debate arising thereon, and continuing;

The hour for Private and Public Bills having expired.

Debate was resumed on the proposed motion of Mr. Marler,—That a Sessional Committee on Railways and Shipping owned, operated and controlled by the Government, be appointed to consider the accounts and estimates and bills relating thereto of the Canadian National Railways, the Canadian National (West Indies) Steamships, and Trans-Canada Air Lines, saving always the powers of the Committee of Supply in relation to the voting of public moneys; and that the said Committee be empowered to send for persons, papers and records and to report from time to time and that, notwithstanding Standing Order 67 in relation to the limitation of the number of members, the said Committee to consist of Messrs. Bell, Byrne, Carter, Cavers, Follwell, Fulton, Gauthier (Lac-Saint-Jean), Gillis, Hahn, Hamilton (Notre-Dame-de-Grâce), Hamilton (York West), Hanna, Harrison, James, Johnston (Bow River), Knight, Lavigne, Legaré, McCulloch (Pictou), Mitchell (Sudbury), Murphy (Westmorland), Nowlan, Power (Quebec South), Richardson, St. Laurent (Temiscouata), and Weaver.

After further debate; the question being put on the said motion, it was agreed to.
