WAR MEASURES ACT-STATUS OF ARMED DEER HUNTERS

Mr. J. M. Forrestall (Darmouth-Halifax East): My question is for the Solicitor General. In his absence I direct it to one of the ministers of the Crown so that perhaps something will be done. On Monday the deer hunting season in Quebec opens for the first time in three years. I am concerned about the safety of non-residents of that province, including Americans, who enter that province for the purpose of deer hunting with all the necessary arms. What is the status of these people under the War Measures Act?

FEDERAL INITIATIVES FOLLOWING EVIDENCE OF MR. SAULNIER BEFORE COMMITTEE

Mr. J. P. Nowlan (Annapolis Valley): My question is directed to the Minister of Justice. It is prompted by the answers of the minister to some earlier exchanges. In view of the fact that the minister understands the federal system and discharges his duties, can he inform the House whether he was one of the ministers who reviewed the evidence of Mr. Saulnier in light of the recommendation in the first report of the Standing Committee on Broadcasting, Films and Assistance to the Arts which was tabled in this House on December 5, 1969, for further study and consideration, as stated in the last sentence of the report? What federal initiatives, if any, were taken between the time of the tabling of the report with Mr. Saulnier's evidence and the opening of the letters by the minister or the Prime Minister which were received from Mr. Bourassa and Mr. Drapeau one year later?

Hon. John N. Turner (Minister of Justice): It is true that evidence was reviewed, Mr. Speaker, but as I have stated in the House on other occasions, the primary responsibility for prosecutions at that time lay with either the police of Montreal or the Attorney General of Quebec. They saw fit not to prosecute.
