### INFLATION—ELUCIDATION OF SALARY AND WAGE GUIDELINE POLICY

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I ask the Minister of Consumer and Corporate Affairs whether he will, with a view to making a statement within the next day or so, confer with the Prices and Incomes Commission which reports to Parliament through him so that the minister can elucidate, on behalf of the Prices and Incomes Commission, the current guideline policy with regard to salaries and wages and what this policy consists of.

In view of the apparent effort of the government to maintain a 6 per cent guideline in respect of settlements, will the minister elucidate what the policy in fact is, and how the Prices and Incomes Commission proposes to influence the provinces to bring about settlements within a 6 per cent level when the federal government has just approved a settlement of 10 per cent?

**Mr. Speaker:** Order, please. I suggest that the minister should not reply to the question now. He might indicate whether he intends to make a statement to the House in due course.

Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, I have read the statement the Minister of Finance made in the House last Monday and the statements by the Prices and Incomes Commission. At the moment I do not see the need for a further statement. I will be happy to table the statements issued by the Prices and Incomes Commission. I am sure the Leader of the Opposition has already read them. I see no need for a further statement today.
