#### Question No. 1.966-Mr. Yewchuk:

- 1. What action is being taken by the government to protect the Canadian people and wildlife against possible damage resulting from the Amchitka nuclear blast?
- 2. Has any information been exchanged and have any discussions been held between Defence Research Board and the United States Atomic Energy Commission concerning the Amchitka nuclear test and, if so, on what date?
- 3. What role was played by the Canadian members of the Arctic Institute of North America regarding the test?
- 4. Does the AINA report regularly to the government and, if so, what was the stand taken by the AINA concerning the nuclear test at Amchitka?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of the Environment and the Department of National Defence as follows: 1. Several monitoring devices were used to ensure the early detection of any threats to the Environment.

- 3. None. A number of Defence Research Board employees are members of the Arctic Institute of North America but such memberships are held on a purely personal basis.
- 4. AINA does not report to the Government regularly and has taken no stand on the Cannikin Test.
- AINA reports to the Defence Research Board only on the results of specific research contracts which may from time to time be awarded to it.

Herb Gray (Minister of National Revenue): In so far as the Department of National Revenue, Customs and Excise is concerned: The importation of literature of this nature, as described in Item 99201-1 of Schedule "C" of the Customs Tariff, is prohibited under Section 14 of this Tariff. ## ESTIMATED TOTAL INCOME OF CANADIANS FOR YEAR 1971

#### Question No. 1,990-Mr. Mather:

- 1. What is the estimated total income of all Canadians for this year?
- 2. What is the estimated total amount in dollars to be paid by Canadians in interest payments of all kinds this year?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): 1. National Accounts income estimates are available only for the first half of 1971. According to the second quarter National Accounts, total personal income in Canada in the first half of 1971, not adjusted for seasonality, amounted to \$34,326 million.
- 2. Estimates of interest payments made by Canadians are not made. The total of interest, dividends and miscellaneous investment income received by Canadians in the first half of 1971 was \$2,848 million.
