Mr. Speaker: Order, please. I will not attempt to rule on the points of order that have been raised, but certainly there is a great deal of noise. I am not sure whether it comes from my left or my right or from where it comes, but it is difficult to hear both the questions and the answers that are given. I think hon. members might want to give members a chance to ask their questions and ministers an opportunity to reply so that we could all hear what is being said.

Mr. Hees: On a point of order-

Mr. Speaker: The hon. member rises on a point of order. We have already spent five minutes on this matter, trying to get on with the first question. I would think that with a bit of good will we might be able to continue now with the question period.

Mr. Hees: My point of order is that if the Prime Minister would answer the questions put to him by the representatives of the people, serious questions wanting to know what the government is going to do to stop the rise in the cost of living we could get on with the question period a lot farther than we have. He sits in his chair and he sulks.

Some hon. Members: Hear, hear!

Some hon. Members: Oh, oh!

Mr. Hees: He is an absolute disgrace.

Some hon. Members: Oh, oh!

Mr. Hees: If any of you guys want to step outside, I am ready for that too.

Mr. Speaker: Order, please. That is not a very valid point of order. Obviously it is a continuation of the dispute. I suggest to hon. members that they should forget about points of order for a moment and return to the question period which is being exhausted slowly but surely by these points of order.
