This Index was then related to the youth population in the area (Population 15-25/Student Job Availability Index), the results of which formed the basis for the allocation of the two-thirds portion of OFY funds. In other words, the funds were allocated to the Areas by taking into consideration job availability and the number of young persons in the Area. The total funds allocated to a Management Area was the sum of the funds distributed on: (1) the basis of the youth population in the area, and (2) the funds allocated using the ratio of Youth Population/Youth Job Availability Index. The total funds allocated to a province was the sum of the funds allocated to all Management Areas within that province.
