Hon. Warren Allmand (Solicitor General): Mr. Speaker, as I said many times, it is not the custom to comment in the House on police investigations while they are under way. I can say this about the Sky Shops investigation: the investigation has been completed and the evidence given to the Quebec Department of Justice for consideration relating to prosecution. All the other investigations are still under way and many witnesses are yet to be interviewed.

REQUEST FOR INVESTIGATION OF CONDITIONS IN INSTITUTIONS

Mr. Lincoln M. Alexander (Hamilton West): A supplementary question, Mr. Speaker, I am not so much concerned about the investigations involving the minister's department. I am talking about the chaotic situation in penitentiaries in which we find a great deal of unrest, overcrowding, suicide—

An hon. Member: From which prisoners escape.

Mr. Alexander: —and questionable administrative practices. I am talking about the institutions at Archambault, Millhaven, Drumheller, about the B.C. penitentiary, Dorchester and, last but not least, Prince Albert. Is the minister aware of the very serious conditions in those institutions? Will he look into the matter? If so, when can we expect action and a report from the minister?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, these are all penitentiaries with very dangerous people incide

Mr. Paproski: You sound more like the Prime Minister every day.

Mr. Richardson: I think the hon. member might direct some of his inquiries on the buildup of aircraft and military equipment to the Soviet Union and the Warsaw Pact countries. We have clear evidence that the Soviet Union has been building up its military strength far beyond its defence requirements. We are playing our part in NATO to help to create a balance of military force which will be strong enough to maintain peace in the world.
