It is also equally true that there are three front doors to the House and only two people guarding those doors, even though there is considerable traffic of Members, staff, assistants, and so on, entering the area.

I do not think that this is a very funny matter, and I hope Hon. Members across would treat it seriously. As one who was an employee of this place for a number of years, it is my hope that due regard will be given to those people who do an excellent job of supervising access and egress to the House of Commons, as I am sure Your Honour, the Sergeant-at-Arms, and others will do in their review of what happened today.

ALLEGED FALSE STATEMENT BY MEMBER

Hon. John C. Crosbie (Minister of Transport): Mr. Speaker, I rise on a point of order with reference to a matter that occurred on Friday when I was not present at the Question Period. I think it is quite a serious matter.

In introductory remarks to a question, the Hon. Member for York South—Weston (Mr. Nunziata) made a completely false statement in what he alleged that I had said. He was asking a question as reported at page 6537 of *Hansard* about the takeover of Canadian Pacific Air by Pacific Western Airlines. As found at the bottom of the page, the Hon. Member said:

—on April 14 I was told by the usually pompous Minister of Transport that there would be few if any jobs lost.

I defy anybody in this House to read the April 14 Hansard or any other source and find anywhere a statement from me that as a result of that takeover there would be few if any jobs lost

I was asked a question by the Member of Parliament for York South—Weston and I made no statement about the number of jobs to be lost, as you will see, Sir, if you look at the page. I was asked a second question on April 14 by the Hon. Member for Regina West (Mr. Benjamin). All I said about the number of employees that might be laid off is this:

However, there has been no indication that any number of the size to which the Hon. Member is referring are to be laid off.

That being 3,000. There is no similarity between that and saying there will be few if any jobs lost, Mr. Speaker.

I submit that we should not continue to allow Members asking questions in this House to make completely false statements leading up to the questions they ask, such as occurred last Friday with the Hon. Member for York South—Weston. Whether it was deliberate or not, I am not in a position to say, although surely he could have checked the record to see what I had actually said.

The continuation of these kinds of wrongful allegations of what are supposed to be facts and the asking of questions on their basis should be stopped. I would ask you to make an example of the Hon. Member for York South—Weston, unless he wants to bear his breast and agree that no such statements were ever made by me and promises to be more careful in the future with respect to the way in which he asks questions.
