Petitions

They decry the fact that VIA is to be cut back and probably terminated in its operations. Indeed, they humbly pray and call upon Parliament to maintain, improve, and modernize VIA Rail service, particularly in those areas of the country where it can provide a more rapid, economical, safe, convenient, environmentally sound, and energy efficient alternative to other means of transportation.

REVISION OF EXTRADITION LAWS

Mr. Bill Domm (Peterborough): Madam Speaker, I have the pleasure to present petitions to the House of Commons. These petitions are spearheaded by the Victims of Violence Society, by the Citizens United For Safety and Justice, and by 31 Members of Parliament from across Canada who are currently collecting signatures on a national petition which will be presented to the House over a period of several weeks. It is expected to accumulate tens of thousands, if not hundreds of thousands of signatures.

It is my pleasure to present a petition today to the House of Commons, including 2,588 signatures mostly from the City of Peterborough and the County of Peterborough, which calls on the Government of Canada to revise its extradition laws in order that we may prevent Canada from becoming a safe haven for criminals. There are five known convicts from the United States in our institutions now.

This petition brings the total to over 36,000 signatures which have been presented to date into the House of Commons.

Mr. Walter Van De Walle (St. Albert): Madam Speaker, I have the honour to present a petition, duly certified correct as to form and content, representing 2,160 Canadians from Alberta, Ontario, and Prince Edward Island.

These concerned citizens call upon the Government to revise the extradition laws to allow for the extradition of criminals immediately or after they have been fully dealt with by the Canadian penal system. These Canadians want the Government to take action to prevent Canada from becoming a sanctuary for criminals.

The number of signatures on petitions now stands at in excess of 38,000.
