The understanding is that there will be no dilatory motions, no additional extensions, no additional legislation or motions brought in if we do go past 6 p.m. and that there will not be a recorded division called for, at least by this party, on the agricultural bill.

Mr. Milliken: We agree with what has been stated, but I think it should be a House order. It should be agreed, by unanimous consent of the House now, that those are the terms. I think the table could properly draft the order.

The Acting Speaker (Mr. Paproski): Is that agreed?

Some hon. members: Agreed.

FARM INCOME PROTECTION ACT

MEASURE TO ENACT

Hon. Marcel Danis (for the Minister of Agriculture) moved that Bill C-98, an act authorizing agreements between the Government of Canada and the provinces to provide for protection for the income of producers of agricultural products and to enable the Government of Canada to take additional measures for that purpose, be read the third time and passed.

Mr. Murray Cardiff (Parliamentary Secretary to Deputy Prime Minister, President of the Privy Council and Minister of Agriculture): Mr. Speaker, I will keep my remarks very short. This piece of legislation we are dealing with, Bill C-98, has had considerable study throughout the country going back to January 9, 1990 when the committee was formed. We have had a lot of consultation right across the country with provincial governments, producers, and the federal government.

I would like to read into the record, with your permission, Mr. Speaker, the names of those people who contributed so much time and help to the process we have just come through: from the Canadian Federation of Agriculture, Don Downe; from the National Farmers Union, Gil Pedersen; from the Atlantic Grains Council, George Burris, secretary—manager of the council; from Quebec, Claude Lafleur; from Ontario, Terry Daynard, executive vice—president of the Ontario Corn Producers' Association; Roger George of the Ontario Federation of Agriculture, an organization which represents many farmers and producers across this country; and Larry Miehls from the Ontario Soybean Growers' Marketing Board.
