(b) The contract called for the operation by CCCJ of a 24-hour, 365-day "on-call" service to provide assistance as required to Open House Canada participants. This would include provision of information, re-routing or accommodation of participants encountering travel problems in transit, and other crisis intervention as appropriate.

For the operation of this service, it was agreed that CCCJ would receive a professional fee of \$44,000 and actual documented expenses not to exceed \$72,000. In fact, CCCJ waived payment of a portion of its fee so that the total amounts paid were:

OPEN HOUSE CANADA

Question No. 294—Mr. Cossitt:

- 1. Did the government carry out an audit of the funds given to the Canadian Council of Christians and Jews in regard to the Program "Open House Canada" and, if so (a) on what date (b) what were the results or recommendations of such audit?
- 2. To the knowledge of the government, in what Canadian cities does the Canadian Council of Christians and Jews maintain offices?

Hon. John Roberts (Secretary of State): 1. The government has received a full and detailed accounting of the expenditures of grants provided by Open House Canada to the Canadian Council of Christians and Jews. A formal government audit has not been carried out as such audits are not required for grants funding. The accounts of the CCCJ are, of course, audited annually by the Council's own auditors, and copies of its most recent financial statement have been made available to the department. Regarding its 1977-78 service contract, CCCJ has agreed to make all relevant records and supporting documentation available to the department for audit at any time.

2. To our knowledge, as of October 25, 1978, the Council maintains offices in: Halifax, Montreal, Ottawa, Toronto, Winnipeg, Calgary, Vancouver.

MULTICULTURALISM—STATEMENT OF MINISTER

Question No. 583-Mr. Mitges:

- 1. Did the Minister of State for Multiculturalism make a statement on June 15, 1978, to the Standing Committee on Broadcasting, Films and Assistance to the Arts, to the effect that the budget of the Multiculturalism Directorate for the fiscal year 1978-79 would be \$7.544 million and, if so, has the government subsequently made the decision to decrease this proposed budget?
- 2. If it is the government's intention to decrease the overall budget of the Directorate, which programmes will be affected and by what amounts?
