Hon. W. L. Mackenzie King Formally Accepts Nomination in Prince County.

DEFENDS WAR RECORD

Did More To Help the Allies Through Industry Than He Could Have at Front.

Summerside, P. E. I. Oct. 3.-Before an audience of 3,500 people, Hon. W. L. Mackenzie King yesterday formally

accepted the nomination for Prince County. Mr. King, who was received with rousing cheers, devoted a considerable portion of his speech to what he said was an attempt to create the false im-

U. S. TROOPERS KILL **NEGROES WHO FAIL** TO OBEY COMMAND

Authorities Claim To Have the Situation At Helena, Ark., Well in Hand.

Helena, Ark., Oct. 3.—With military control established at Elaine, eighteen miles south of this city, centre of the negro disorders which for 48 hours have thrown Helena and Phillips County into turmoil, and other villages where the negro population predominates, the task of pacification was declared well ways today. negro population predominates, the task of pacification was declared well under way today.

The white casualities as a result of clashes which occurred at intervals since the first outbreak on Tuesday night, stood today at five dead and five wounded. So far more than 200 negroes have been taken into custody by the military and held under guard at Elaine. The known negro dead today was fourteen, with other bodies reported in the cane brakes and underbrush about Elaine, where most of the fighting occurred.

TO HOLD BACK PAY

Action of the Government Is Strongly Condemned by Many Influential Newspapers — The Government Defends Its Policy by Maintaining Move Is Made To Hasten End of the Dispute.

London, Oct. 3.—Negotiations between the Government and labor representatives other than railwaymen were resumed today in an effort to bring the authorities and the railway representatives together for a settlement of the railroad strike.

Crowds thronged Downing street this morning in expectation of a resumption of the conferences between the transport workers representatives and other trade unionists with Premier Lloyd George in the endeavor to mediate in the strike situation. The crowds were orderly, but the police nevertheless caused them to quit Downing street and move into Whitehall.

At an early hour a conference took place on the Government side in which the premier George N. Barnes, minister without portfolio, Sir Robert Horne, the minister of transportation, participated. At that time, no hour had been fixed for the renewal of the mediation effort, but shortly after noon it was learned that a deputation of the transport men and associated unions had gone to confer with the premier and the ministerys.

"The members of the National Union of Railwaymen broke their contracts and stopped work without notice, in complete disregard of the effect their action would have on the persons and property of ordinary citizens in their charge. They inflicted damage on innumerable people, left food upon which the public depended for subsistence to go to waste, put vast numbers to great expense by leaving them stranded without conveyances, and inflicted great losses on many by preventing them from reaching destinations. The damages to which they are liable in law are vastly greater than the amount now being withheld.

In the meantime the country is still subjected to unexampled injury by the railwaymen's action, and in these circumstances the government would not be justified in handing over to the strikers a sum which would be used for prolonging a struggle undertaken without any consideration for the welfare



Several newspapers comment adversely on the decision to withhold the payment of the last week's pay of the men. It is admitted the government's action hangs on a strictly legal point, but it is urged it will infurfate the strikers. The Mail says this action will "spoil the government's handling of the situation," and denounces it as a "signal folly."
