#### WITHDRAWS HER SUIT AND AVOIDS SCANDAL

Duchess of Orleans and Duke Will Settle Grievances By Arbitration.

[Canadian Press.] Brussels, Belgium, Jan. 13. - The Duke and Duchess of Orleans, desiring to avoid scandal and the cost of the proceedings agreed today to withdraw from the courts the suit started by the duchess for separation, alimony and the restitution of large sums she had advanced to her husband. They agreed also to submit to arbitrators the questions of the property and of the amount the duke should

allow his wife after separation. The bringing of the suit by the duchess aroused great interest in Europe where the duke is recognized as the pretender to the French throne. while the duchess, to whom he was married in 1896, was formerly the Archduchess Marie Dorothea Amelia of Austria. No children have been born of the union.

## **GIRL'S DEATH NOT CAUSED CRIMINALLY**

of Addie Weeks.

etter Written by Friend Introduced, and Suitor Tells of His Relations With Her-Police Investigate.

Weeks came to her death at 499 Ottaway avenue, in this city, on Wednesday, Jan. 7, 1914; from internal hemorrhage and shock. The post-mortem did not disclose any criminal interference as causing or contributing to her death."

This was the verdict brought in by the jury last night in the inquest into the death of Addie Weeks, who died suddenly while eating dinner at the home of a friend, Mrs. Jennie Mc-Dermid, 499 Ottaway avenue.

Dr. McWilliam, who was called to attend Miss Weeks at the time, made the post-mortem. He explained that there were no marks on the body to show that any instruments had been No chemical examination the contents of the stomach was made. No Analysis Made.

Coroner Dr. Robert Ferguson, who held the inquest, told The Advertiser that to have such an examination made it was necessary to get the crown prosecutor's approval, and then to forward the stomach, with its contents, to the Dominion analyst. Even had the stomach been examined chemically and the presence of any drug found there, it would still be necessary to find out whether such drug was self-administered or given by another. In view of these considerations it was thought unadvisable

her to her "fate." What Was Her "Fate?" Mr. McKillop asked the witness what he meant by the word "fate." The answer was that since Miss Week was alone in the world, without relatives, he would not leave her to face her homeless condition alone. per further testified that he did not know of the girl's physical condition and had never gone with her to any such house as that referred to in his letter. One phrase in the letter said. 'We will be able to pull through somehow." This was explained by

Harper as referring to his being the girl's suitor. Known by Two Names. Other evidence showed that Miss Weeks was known also as Miss Oakes. although no explanation was given

or this alias. When the girl returned to this city from a visit to her old home near Middlemiss, she returned to her former boarding-house on Maple street on Jan. 6, and as she had told the proprietor there that she might not return, her room had been rented. Miss Weeks called the same evening, and meeting a girl friend at this house told her that she was going to look for a room. There was no evidence adduced to show whether Miss Weeks had secured the room or not. She called on Mrs. McDermid the next day, and it was during that call

It is understood that the police de partment, intends to look further into the visits of Miss Weeks to different addresses in the city, with a view to finding out whether there was any criminal administration of drugs.
