CANADIAN NATIONAL STEAMSHIPS—SALES AND TRANSFERS

Mr. BELL (St. Antoine):

1. At what price were the Canadian Gunner, Canadian Harvester, and Canadian Settler sold, in 1926?

2. To whom were they sold, and have they been paid for in full?

3. At what price were each of the seven steamers, Canadian Aviator, Canadian Gunner, Canadian Harvester, Canadian Otter, Canadian Runner, and Canadian Sapper transferred from the merchant marine fleet to the Canadian National steamships?

Mr. DUNNING:

1. Canadian Gunner, \$50,000; Canadian Harvester, \$50,000; Canadian Settler, £17,750, less $2\frac{1}{2}$ per cent commission.

2. Canadian Gunner, Canada Atlantic Transit Company, Toronto (a subsidiary of Canadian National Railways); Canadian Harvester, Canada Atlantic Transit Company, Toronto, (a subsidiary of Canadian National Railways); Canadian Settler, to the Arbour Shipping Company, London, England.
