ERNEST CÔTÉ, NATIONAL MUSEUM

Question No. 1,400-Mr. Fisher:

What responsibility has Ernest Côté had in the past ten years for the national museum, in general and in terms of directives or memoranda or instructions given him?

Answer: Subject to the directives of the minister and, until July 1, 1963, of the deputy minister, he had the general responsibility for the policies affecting the development of the national museum for most of this period.

BENEFITS TO DESIGNATED AREAS IN MANITOBA

Question No. 1,405-Mr. Simpson:

What benefits, if any, will accrue to designated areas (a) in the municipal district of Dauphin (b) in the district normally coming within the administration of the Dauphin branch of the unemployment insurance commission (c) other areas of the province of Manitoba?

Mr. MacEachen: (a) and (b) All municipalities located in the area serviced by the Dauphin local office of the national employment service, which has been designated as an area of high winter unemployment, will be entitled to a federal contribution of 60 per cent of direct payroll costs incurred on approved projects under the municipal winter works incentive program. This area will also qualify in connection with the supplementary federal government winter construction program, which applies to designated development areas and designated areas of high winter unemployment.

(c) The Dauphin local employment office area is the only area in Manitoba which has been designated.

FEED GRAIN BOARD OF EASTERN FARMERS

Question No. 1,411-Mr. Laverdiere:

Is the government considering setting up a feed grain board, to consist of eastern farmers and modelled on the Canadian wheat board and, if so, will that feed grain board have a responsibility of buying and selling feed grain on behalf of eastern farmers, and to provide for adequate storage of feed grain?

Mr. Hays: Representations with respect to a feed grain agency for eastern Canada are being considered by the government.

SPONSORED IMMIGRANTS RECEIVING WELFARE PAYMENTS

Question No. 1,415-Mr. Prittie:

Is it possible, from records maintained by the Department of National Health and Welfare, to determine (a) the number of sponsored immigrants

who are in receipt of old age security benefits, disabled persons' allowances and blind persons' allowances at the present time (b) the number of sponsored immigrants who will be eligible for such allowances by the year 1970, and (c) the estimated cost of the allowances to such persons at present and projected to 1970?

Miss LaMarsh: No, the information asked for is not available.

CHIEF ARCHAEOLOGIST, NORTHERN AFFAIRS DEPARTMENT

Question No. 1,419-Mr. Fisher:

Has the minister of northern affairs under consideration the appointment of a Mr. Taylor to the post of chief archaeologist of Canada and, if so, what are Mr. Taylor's qualifications in detail, including the archaeologists under whom he has worked?

Answer: This question presumably refers to the chief of the archaeology section of the national museum. Appointment to this position is not the responsibility of the minister but of the civil service commission. However, I should advise the hon. member that the civil service commission appointed Mr. W. E. Taylor, Jr., who had been acting chief of the section, as chief, effective July 10, 1963. Mr. Taylor's qualifications follow:

- 1. Academic background: B.A. (Honours) anthropology, U. of Toronto, 1951, A.M. sociology, U. of Illinois, 1952; graduate fellow, U. of Illinois, 1951-52; graduate fellow, U. of Illinois, 1952-53;; teaching fellow, U. of Illinois, 1953-54; research assistant, U. of Michigan, 1954-55; research assistant, U. of Michigan, 1955-56; post-M.A. student, U. of Illinois, 1952-3, 1953-4, "A" standing; post-M.A. student, U. of Michigan, 1954-5, 1955-6, "A" standing; passed Ph.D. oral and written examinations, May 1956, U. of Michigan; Ph.D. pending submission of dissertation; won but declined graduate fellowships and assistantships at several universities including Chicago, Arizona, Kentucky, Wisconsin, Harvard, and North Carolina.
- 2. Publications: He has published 28 titles, has one in press, two others ready for submission, and is preparing five others. He is also compiling, editing and contributing to a large volume, "The Archaeology of Canada" to be published by the museum. He has represented the museum and read technical papers at international meetings.
- 3. Experience: Between 1947 and 1963, he has participated in 25 field projects in Ontario, Quebec, Newfoundland, Illinois, Arizona, Michigan and the Canadian Arctic. In the last named, his area specialization, he has passed 11 field seasons. He has been invited to join archaeological expeditions to Alaska, Greenland, Egypt, Mexico, and Ecuador. He has examined museums in Canada, the U.S.A., Mexico, Scotland, England, France, Belgium,
