- 1. This information is not available as classification stamps and seals are commercially manufactured by most engraving companies and sold in most office supplies and stationery stores. Many departments utilize a typewritten classification rather than rubber stamps.
- 2. Clerks, typists, stenographers, secretaries may use any classification stamp or seal provided they have been properly cleared and are acting under the direction of a person authorized to classify information.
  - 3. No, they do not require special protection.
