NUCLEAR ARMAMENTS

TESTING OF CRUISE MISSILE—MOTION UNDER S.O. 43

Miss Pauline Jewett (New Westminster-Coquitlam): Madam Speaker, I rise on a matter of urgent and pressing necessity under the provision of Standing Order 43. In light of the dramatic escalation of the nuclear arms race; in light, particularly, of the development and planned deployment of the Cruise missile, a new weapon with great sophistication, accuracy, undetectability and potential "first strike" use; in light of the fact that two of our five NATO partners that have been asked to base these missiles within their borders have so far refused to agree; and in light of the need both to suffocate the nuclear arms race and prevent the Soviet Union from seeking a weapon equivalent to the Cruise missile, I move, seconded by the hon. member for Saskatoon East (Mr. Ogle):

That this House endorse the Prime Minister's strategy of nuclear suffocation as presented to the United Nations in 1978, take note of the refusal of two NATO partners, the Netherlands and Belgium, to have the Cruise missile deployed on their soil, and urge that Canada, in the interest of freezing the nuclear arms race, refuse to allow the testing of this new generation of nuclear weapons on Canadian soil.
