The Hon. Member knows that a project of that kind must clear all necessary legislative challenges and requirements before any Minister can stand in this House and make an announcement one way or the other.

## CANADIAN ARSENALS

PRIVATIZATION—EMPLOYEES' PENSIONS—MEASURES  
GOVERNMENT INTENDS TO TAKE

**Mr. Don Boudria (Glengarry—Prescott—Russell):** On behalf of the 800 Montreal employees of Canadian Arsenals, Mr. Speaker, I direct my question to the President of the Treasury Board.

The Minister will know that the result of privatizing Canadian Arsenals will be a considerable reduction in employee pension benefits, to such a degree that some of them stand to lose \$17,000 a year.

What does the Minister intend to do to help these employees? Or does he plan to stick to the usual Conservative justice standards and do nothing at all?

**Hon. Robert de Cotret (President of the Treasury Board):** This morning, Mr. Speaker, I met with Public Service Alliance spokesmen before holding discussions with representatives of the Canadian Arsenals union concerning a problem we have been talking about for a number of months, namely pensions.

I can assure my colleague that in the case of the 600 Canadian Arsenals employees the provisions of Bill C-87 contain a prospective solution which they should all find fair and equitable.
