Ms. Jewett: The petitioners also ask, Mr. Speaker, that Canada be declared a nuclear-weapons-free zone and that wasteful spending on the arms race be diverted to fund human needs as to ensure prosperity through peace. And as in duty bound, your petitioners will ever pray.

CRIMINAL CODE

AMENDMENT RESPECTING CAPITAL PUNISHMENT FOR CERTAIN OFFENCES

Mr. Domm: Mr. Speaker, the purpose of this Bill is to amend the Criminal Code, thereby permitting capital punishment for everyone who commits high treason and everyone who commits first degree murder.

OFFICIAL LANGUAGES

MEASURE TO AMEND

Mr. Jean-Robert Gauthier (Ottawa-Vanier) moved for leave to introduce Bill C-203, an Act to amend the Official Languages Act (supremacy of the Act) and to amend other Acts in consequence thereof.

Mr. Speaker: Is it the pleasure of the House that the Hon. Member shall have leave to introduce the Bill?

Some Hon. Members: Agreed.

Mr. Gauthier: Mr. Speaker, the purpose of this Bill is to affirm the supremacy of the Official Languages Act over all other legislation and regulations of Parliament. It provides amendments to the Bank Act, the Railway Act and the Winding-up Act with a view to stressing its characteristic as the basic Canadian legislation.

Mr. Speaker: Is it the pleasure of the House to adopt the motion?

Some Hon. Members: Agreed.

Motion agreed to, Bill read the first time and ordered to be printed.
