# CLOSURE OF CANEXEL IN GATINEAU, P.Q.

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is directed to the Hon. Minister of Employment and Immigration.

Last week, the Canexel company in Gatineau announced that it would be closing down on February 14, thus putting about 200 employees out of work. During the election campaign, the Progressive Conservative Party talked a great deal about job creation. In view of the impending situation in Gatineau, I would like to know what the federal Government intends to do about the possibility of keeping this factory open and saving 200 jobs.

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, I can inform the Hon. Member that we are aware of the problem and are taking every possible action to improve the present situation. For instance, we are prepared to set up a committee with the employer and employees and to consider training, mobility and adjustment programs for all employees concerned.

# **CLERK OF PETITIONS' REPORT**

#### PEACE CAMP ON PARLIAMENT HILL

Mr. Speaker: I have the honour to inform the House that the petition presented by the Hon. Member for Ottawa Centre (Mr. Cassidy) on Friday, November 16, 1984, meets the requirements of the Standing Orders as to form.

I must also, however, advise the House that there is some doubt in my mind as to the acceptability of this petition. Citation 688(1) of Beauchesne's Fifth Edition states:

Aliens, not resident in Canada, have no right to petition Parliament.

The precedents in our practice are not as decisive as they are in other jurisdictions. While I must report today on the form of the said petition-I am required to do so in fact by the rules of the House-I wish to advise the House that I am entering a caveat on the propriety of certain signatures of non-Canadian citizens pending further study on the matter.

Mr. Cassidy: I have a point of order, Mr. Speaker, I submitted this petition, and since the overwhelming number of signatories to the petition are in fact Canadian citizens, indicating that they-

Mr. Speaker: Order. The very reason that I indicated I was raising a caveat on the matter and wished to study it further is precisely the point the Hon. Member for Ottawa Centre is making. I wish to advise both him and Hon. Members of the House that I do not propose to make a ruling today ruling the petition out. However, I do want to make it clear to the Hon. Member-and I know it is a serious petition for him as well as for others-that there are traditions about who can and who cannot petition the House of Commons. In the past, Speakers have ruled that petitions containing any names other than Canadian are simply not receivable. It is for that reason that I am reserving a judgment until I look at the precedents further. I will be making some comment on it later.
