## Air Canada

We wondered, as the Deputy Prime Minister introduced in the House a Bill to abolish Air Canada as a Crown corporation, whether it was not the beginning of the end for Canada. We must recognize that in the case of Air Canada, we will have to make up deficits from time to time and pay more in order to provide service to all Canadian men and women because, whether they live in Hamilton, Paulatuk, Red Deer, Cold Lake or anywhere else, they should be entitled to the same services provided by a Crown corporation. Once Air Canada has been privatized under this legislation, why should it fly to Tuktoyaktuk or Inuvik? Why should it fly to the Northwest Territories or the Yukon if it is not profitable?

Mr. Speaker, I feel I have no choice but to ask the Deputy Prime Minister, who is a reasonable man, to accept the rationale I have put forward tonight. I have no alternative but to move the following amendment. Therefore, I move:

That the motion be amended by striking out all the words following the word "that" and substituting the following therefore:

Bill C-129, An Act to provide for the continuance of Air Canada under the Canada Business Corporations Act and for the issuance and sale of shares thereof to the public, be not now read a second time, but be read a second time six months hence".

Mr. Speaker, it is reasonable amendment and I know that the Government will accept this motion, seconded by the Hon. Member for Ottawa Vanier (Mr. Gauthier).
