1. Organization of American States (OAS)—CICAD Meeting Ixtapa, Mexico.

PURPOSE

The acronym CICAD comes from the Spanish language title of the *Inter-American Drug Abuse Control Commission*. CICAD, an agency of the OAS, was established in 1986 to implement the Program of Rio (Inter-American program of Action of Rio de Janeiro against the Illicit Use and Production of Narcotic Drugs and Psychotropic Substances and Traffic/therein).

The ministerial meeting was proposed through a resolution of the OAS in October, 1989 for the purpose of re-evaluating the current status of the drug problem in the OAS region and the re-establish priorities for inter-American action in the context of the Program of Rio.

COST \$2,614.25. The Solicitor General departed Canada on April 16, 1990 and returned on April 21, 1990.

2. *TREVI Meeting* in Dublin, Ireland, with related bilateral meetings in London, England.

PURPOSE

TREVI is a grouping of European Community ministers responsible for security issues and law enforcement. Concern over the threat of terrorism prompted a decision to form the Trevi Group in 1976. Canada, along with the United States and other nations, is an observer country. Canada, however, participates formally in a meeting with the "Troika", the three European Community ministers responsible for the TREVI meetings. Canada takes advantage of the occasion to dialogue on a

bilateral basis with international counterparts on issues of mutual concern.

COST \$8,528.48. The Solicitor General departed Canada on June 12, 1990 and returned on June 19, 1990.
