will set out the circumstances under which my good friend can buy the glue necessary to build his model railroads, which is what I think he is primarily interested in.

Honourable senators, it is all very well to say in this house or elsewhere that once people have been warned they should take action. As to glue sniffing. I remember after there had been a fatality or two right here in the Ottawa area, that both the newspapers sent out reporters to investigate. We all recall the story. We read of how reporters went into stores, and were able to buy the glue without any trouble, and that the young fellows they sent in to buy it were also able to obtain it. In fact, when one reporter purchased half a dozen tubes of glue, the sales clerk put them in a bag, saying, "Have a good trip." This was all reported by newspaper reporters, and not by the Consumers' Association which has taken such a roasting here.

I have no doubt that we are going to be able to get all the household bleaches, and pipe and drain cleaners that we need. I have no doubt that the bona fide model builder is going to be able to get his glue. But, I hope that the regulations will provide some protection, and will ensure that these articles are not put holus bolus into the hands of ignorant or innocent people.

Hon. Mr. Thorvaldson: There is nothing at all concerning that in this bill.

Hon. Mr. Prowse: If my honourable friend would read the bill, and keep an open mind on it, and ask himself what it is supposed to do, he will discover that it is in the bill. I cannot think of anything else that is meant by clause 7. I cannot think of anything that could possibly be intended other than that the Governor in Council may make regulations authorizing the advertising, sale or importation into Canada of any hazardous product included in Part II of the Schedule, and prescribing the circumstances and conditions under which, and the persons by whom, such hazardous product may be sold, advertised or imported into Canada, and respecting the powers and duties of inspectors and analysts, and so on. I do not want to bore the house by reading all the details, because honourable senators can read for themselves. I do say that the bill sets out a procedure that will give us some protection.

If honourable senators read the section that provides for inspectors they will see that the words are not "may appoint as a hazardous products inspector", but "may designate as a hazardous products inspector". I take the use of the word "designate" instead of the word "appoint" to mean that the minister will merely designate members of provincial boards of health, members of city boards of health, R.C.M.P. officers, food and drug inspectors, or people who are already on some payroll, to carry out these duties in addition to the duties they now perform. This would be the natural and normal way of doing it. If my honourable friend were correct, and we were going to set up a whole body of inspectors to do nothing else but shop around looking for these products, then we would need a great many to cover the whole of Canada, and they would have nothing to do for 364 out of the 365 days of the year.

I suggest that this bill provides a reasonable way of giving some protection. Surely when we are doing something that may do that, if we save one life, nobody can say we have been wasting our time or that we have done something we have no right to do.
