Mr. *Kaulbach*—On Wednesday next—ORDER OF THE HOUSE for all Papers and Correspondence in connection with *James E. Dauphinee*, of Bridgewater, as Local Warden of River Fisheries on Lahave River, County of Lunenburg, N. S., from March 30th, 1869, to the present date ;

Also, all Papers and Correspondence during said period respecting application by said *James E. Dauphinee*, through the Representatives of said County, for compensation for loss and injury sustained by him whilst acting as such River Warden.

“ The revenues, earnings and all moneys accruing to and received by the Company in respect of the Branch Railway, the construction whereof is hereby authorized, shall be chargeable, in the first place and by priority, with the payment of all claims for land taken for right of way along the said Branch Railway.”
