CBC COVERAGE OF TORONTO BLUE JAYS SPRING TRAINING CAMP

Question No. 2,345—Mr. Friesen:

- 1. How many CBC (a) TV reporters (b) radio reporters (c) cameramen (d) soundmen (e) other technicians covered the spring training camp of the Toronto Bluejays and, in each case, how long were they on this assignment?
- 2. (a) How many pieces of material were submitted by the reporters for (i) radio (ii) television (b) how many of the reports were aired (c) how many minutes of air time did this involve?
- 3. How many CBC (a) reporters (radio and television) (b) cameramen (c) soundmen (d) other technicians cover each of the provincial legislatures while they are in session?

Hon. John Roberts (Secretary of State): I am informed by the Canadian Broadcasting Corporation as follows: 1. English Services: (a) Four sports commentators; (b) one sports commentator; (c) three staff, one freelance; (d) one; (e) one. One producer, one unit manager, one director, one production assistant and one script assistant were also assigned. The above staff were assigned as follows: TV-A crew of eight spent three weeks, a unit manager spent four days and a commentator spent five days preparing a one-hour special (fully paid for by its sponsor). One commentator and one cameraman spent March 6-14 producing items daily for two Toronto local sportscasts plus longer items for Toronto local evening news shows. All items were syndicated to CBC stations across Canada. One commentator and one cameraman spent March 25-April 3 producing a half-hour Toronto local special plus items for two daily Toronto local sports shows. Items were syndicated. A director spent one day directing an item for 90 Minutes Live, a national program, using the sports camera crew already on location. One commentator spent three days covering the camp for network news, network weekend sports shows and Toronto local station. Radio—Staff member from national sports desk of national newsroom spent two days providing items for national newscasts, plus a 15-minute item for network sports program Rebound. French Services: (a), (b) one (c) two (d) one (e) nil. One producer and one script assistant were also assigned. The French Services television crew was in Florida to cover the Montreal Expos training camp. At the end of that assignment the crew spent one day at the Blue Jays camp preparing three network television items.
