Here, without any statement in evidence emerging to warrant such a recommendation, the jury added a rider to their verdict that they extend to Mrs. Harkness a plea for mercy which the Secretary for Scotland accepted and interposed with a reprieve.

The interference of the jury in this way irretrievably sent Harkness to the gallows—as the Secretary could not doubly in such a brutal crime extend the act of clemency—and yet those who were in the closest contact in prison with Harkness were agreed that he was the less guilty of the two. Indeed, the highest possible authority on that point indicated to the writer, while he was handling the pack of cards with which Harkness had played "Patience" in the condemned cell, that he was satisfied Harkness did not kill the girl. The fault of his death really lay with the jury's rider; as no doubt, in mercy to the woman, they thought they were doing a very humane act. But they forgot that Harkness could not as a man, go into the box and say anything against his wife.
