London, Tuesday, April 29.

AN Ottawa correspondent telegraphs that  
hundreds of electors who were entitled to  
be on the voters' lists in Ottawa went to  
the polls on Saturday, and were told by  
the returning officers that they were not on  
the list. It is again made evident, as it  
was made evident in London some time  
ago, that the Dominion voters' lists are not  
only expensive and unnecessary—the muni-  
cipal lists being far more complete—but are  
grossly inaccurate.

AFTER all the talk about Mr. Meredith's  
London speech, who would have thought  
that it was not an original production, but  
the product of a country doctor? So we  
are told by the Walkerton Telescope,  
which announces that Dr. Tennant, of  
Lucknow claims the paternity of the oration.  
This is a bad blow, but it still leaves the  
Opposition leader in undisputed possession  
of one great effort—"The Facts for the  
Irish Electors," issued as a leaflet in the 1883  
campaign, and withdrawn when it was  
found not to work.

FRIDAY next is Arbor Day in the public  
schools of Ontario. No happier or more  
useful custom has ever been established.  
Hon. G. W. Ross, the Minister of Educa-  
tion, in his last annual report, says the day  
has become one of the most interesting days  
in the year. In 1885, 33,940, in 1886, 34,  
087, in 1887, 28,057, in 1888, 25,714 trees  
were planted, and last year about a similar  
number were put down. In a very few  
years every rural section in the Province  
will have its pleasant, shady bower where  
the pupils can find shelter from the scorch-  
ing sun during the summer months, and  
where their taste for the beautiful in nature  
will find the same gratification.

OTTAWA city, in which an election to  
fill a vacancy was held on Saturday, has  
always been a Tory stronghold in Domi-  
nion contests, and with that party in  
power in a bye-election the prospects of  
defeating its nominee could not be re-  
garded as brilliant. Yet, if we were to  
take the Tory method of figuring out the  
returns in contests where three candidates  
run, we should say that though Mr.  
Macdonald carried the seat by a  
majority of 886, the Government was  
really defeated. The combined vote polled  
by the Liberal and Equal Rights candidates,  
both against the Government, was 2,848,  
whereas the Tory candidate only polled  
2,463—there being thus a clear majority  
against the Administration. In like man-  
ner the Tories figured out a defeat for the  
Ontario Government in the West Lambton  
contest. How do they like the Liberal  
corn to be measured by their half bushel?

THE DEVISE OF THE ENEMY.  
It is a noticeable fact of the present cam-  
paign in Ontario that in constituencies  
where the Equal Rights movement is sup-  
posed to have made some progress, and  
where a candidate running as a straight  
Conservative would have no chance of elec-  
tion, the plan is to put up some man of re-  
liable Conservative antecedents as an Equal  
Rights nominee and quietly accept him as  
the candidate of the Conservative party.  
John Carnegie, a stiff-necked Tory of the  
old Bourbon school is in this way standing  
as an Equal Rights man in West Perth-  
burgh, and Alex. Shaw, another hard-  
shell Tory, is standing in Center Bruce.  
This is part of the organized plan of Mr.  
Meredith and his political friends, as is  
clearly proved by a circular letter recently  
sent out to prominent electors in the Pro-  
vince by Secretary Boswell, of Toronto, with  
the view of entrapping them. Here is an  
extract from the precious circular:

"The mode of accomplishing this is to run  
independent candidates in about 30 ridings  
in which Mr. Meredith's party cannot win, thus  
securing say half that number of seats from  
Mr. Meredith's side, and secure the balance of  
power between the two parties, and be able to  
dictate terms to them. By not opposing Mr.  
Meredith in the ridings that he can carry, we  
can get a solid Conservative vote, and our  
platform will bring us enough ultra-Protes-  
tants to win the election. . . . You  
find that you stand in such position in  
your riding of— . . . that if you were to name the  
candidate on this platform you could win  
easily and without a peradventure. You could  
get the solid Conservative vote, and the  
ultra-Protestants who would rather vote  
against—than have Catholic rule. A  
requisition circulated by your friends would  
commit enough Reformers to you before you  
accepted to make your election an assured  
fact.  
And so in accordance with this scheme  
men like Carnegie and Shaw are being put  
into the field under pretense of being in-  
dependents to try and steal enough Reform  
constituencies to get a majority in the Leg-  
islature for Mr. Meredith. For men who  
profess to be moved by lofty regard for  
Protestant Christianity this is one of the  
most contemptible dodges in political  
annals, and we believe the people of  
Ontario will resent it as such. How  
ministers of the gospel can allow them-  
selves to become parties to such evil de-  
vices, as a few seem to have become, just  
as others allowed themselves to be misled in  
the anti-Slavery selections crusade of 1868,  
we cannot pretend to understand. But the  
object is palpable enough: it is to drive out  
of office an upright and honorable Christian

statesman, whose private and public life is  
without a stain, and secure his place for a  
man who has so far resorted to every im-  
aginative scheme in vain to get a Conserva-  
tive majority.

How does it happen that in such strong  
Tory constituencies as East Durham, Card-  
well, Carleton, Leeds, East and West Hants,  
South Norfolk, North Perth or South  
Grey no independent candidate is offering?  
How is it, indeed, that in no constituency  
represented by a supporter of Mr. Meredith  
is there any Equal Rights or independent  
nominee in the field?

Simply because the movement is a Tory  
plot to beat Mr. Meredith. It is the  
business of the electors to stamp out  
such knavish conspiracies, whether  
masquerading under the cloak of  
"Equal Rights" or "Educational Reform,"  
party, and we feel assured that when the  
voice of Ontario is heard it will be a  
righteous condemnation of the faction now  
seeking to create religious strife under  
the leadership of Mr. Meredith.

INDEPENDENT PRAISE.  
Some opponents of the Meredith Govern-  
ment, pretending to be zealous for the pro-  
motion of temperance, never lose an op-  
portunity to belittle the aid which the On-  
tario Administration has afforded to legiti-  
mate temperance effort. Such men cannot  
go to the leaders in the temperance move-  
ment—the unselfish workers for the pre-  
vention of intemperance—for comfort. The  
principal temperance periodicals warmly  
praise the Administration, and even the  
Dominion Alliance, over which presides  
Hon. A. Vidal, of Sarnia, thus refers to
