3. Scale of salary payments for these positions in External Affairs service is as follows:

1. Minister, \$8,000 to \$10,000.
2. Counsellor, \$5,760 to \$7,200.
3. Second Secretary, \$3,300 to \$4,260.

LOANS RAISED OUTSIDE OF CANADA

Mr. AYLESWORTH:

1. Have any loans been raised outside of Canada during the present fiscal year?
2. If so, where were such loans floated and what was the total amount and terms of each such loan?
3. For what purpose was each such loan raised?

Mr. ILSLEY:

1. Yes.
2. A Dominion of Canada loan was issued in New York in January, 1943, on the following terms:
 - \$30,000,000 five year 2½ per cent bonds dated January 15, 1943, due January 15, 1948, sold to the underwriters at 99¼ per cent;
 - \$30,000,000 ten year 3 per cent bonds dated January 15, 1943, due January 15, 1953, sold to the underwriters at 99½ per cent;
 - \$30,000,000 fifteen year 3 per cent bonds dated January 15, 1943, due January 15, 1958, sold to the underwriters at 96¾ per cent.
3. The proceeds of the sale of the bonds, together with cash from the treasury, are to be applied to the redemption of \$100,000,000 Dominion of Canada thirty year 5 per cent bonds dated May 1, 1922, due May 1, 1952, called for prior redemption on March 15, 1943.
