Mr. BRACKEN: I understood the Prime Minister to say that tomorrow we would proceed in committee with Bill No. 3.

Mr. MACKENZIE KING: No, today.

Mr. BRACKEN: I understood the Prime Minister to say tomorrow as well, and I had previously understood that tomorrow and Thursday were to be given to the speech from the throne.

Mr. MACKENZIE KING: I am sorry if I did say that. I meant to say that this afternoon we would continue with the emergency measures, on Wednesday and Thursday with the debate on the address, and on Friday take up the emergency measures again. I am now saying that on Friday we may not take up the emergency measures at present being considered, but we shall seek between now and Friday to arrange either to continue the debate on the address or to take up some other emergency measure as may best suit the convenience of the house.

Mr. ADAMSON: I understood the Prime Minister to say that it was the intention to proceed with a measure of the Minister of Finance on Friday instead of going back to the speech from the throne. Is it the intention of the minister to proceed with the gold measure, or some other matter?

Mr. ABBOTT: I had not given special consideration to that, Mr. Speaker. The measure to assist the gold mining industry is on the order paper and it could be proceeded with at any time. It is not as urgent as some of the others, but perhaps we can give the question consideration between now and Friday.

SUGAR BEETS

REQUEST FOR ANNOUNCEMENT OF 1948 PRICE INCREASE

On the orders of the day:

Mr. J. H. BLACKMORE (Lethbridge): I desire to direct a question to the Minister of Finance, based upon a newspaper report of January 12, 1948. The report states that on January 12 was announced the 1948 increase in price for tomatoes, peas for canning, sweet corn and green beans, crops which compete with sugar beets in the labour market. In the light of these facts, will the minister tell the house when he will make known what increase the government will render possible to producers in the price per ton of beets for sugar making in 1948?

Hon. DOUGLAS ABBOTT (Minister of Finance): The hon. member for Lethbridge was good enough to give me notice of the question and I can best answer it by repeating

the last paragraph of the statement I made on November 3, 1947, when sugar rationing was abandoned. The paragraph reads:

The government does not propose to subsidize the production of sugar beets in 1948, nor does it propose to sell imported cane sugar on a subsidized basis. Beet sugar may therefore be expected to sell at prices in line with average laid down duty paid costs of imported cane sugar.
