Hon. Leo Cadieux (Minister of National Defence): Not necessarily, Mr. Speaker.

INQUIRY RESPECTING FEDERAL CO-OPERATIVES MEASURE

Mr. John Burton (Regina East): Mr. Speaker, I wish to direct a question to the Minister of Consumer and Corporate Affairs. Will the government introduce its long promised federal co-operatives act before the summer recess?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, the legislation is being drafted by the Department of Justice, which has had an extremely heavy work load this spring. I am hopeful of being able to introduce the bill for first reading before the summer adjournment so that people can have sufficient time to study it and make representations to me. If I am not successful in introducing it before the summer recess, however, an opportunity will be afforded to the provincial governments and other interested parties to make representations to me on the bill.

Mr. Burton: As a supplementary question, has the minister consulted with the co-operative organizations in preparing this legislation and do they agree that it takes years to prepare such a bill?
