Generally speaking, however, in the first instance it would be the government of a particular province, in this case, Quebec, which would ask for designation.

REQUEST FOR ASSURANCE OF ADEQUACY OF SUPPLIES FOR FEED MILLS IN VIEW OF EXPORT EMBARGO

Mr. Jack Murta (Lisgar): Mr. Speaker, I should like to return to the first question I directed to the Minister of Industry, Trade and Commerce. Is the government satisfied at this time that the present arrangements between Canada and the United States will avert any further escalation of feed costs, and also will the government assure the House that feed mills in Canada will not run out of soybean meal in the forseeable future?

Hon. Alastair Gillespie (Minister of Industry, Trade and Commerce): Mr. Speaker, it is precisely because of the uncertainty regarding such questions as supply and price that the government acted last Friday by imposing export controls on the listed commodities, seven all together. That is also the reason my statement, in answer to the hon. member's first question, indicated a procedure for determining what the forward commitments might be. It is only after we have determined these forward commitments that we would be in a position to indicate whether an export permit should be granted, giving due and important allowance to domestic supplies.

Mr. Murta: Mr. Speaker, I have a supplementary question in that connection. In view of the quantities of our committed export orders I should like to ask the minister whether we can be assured of operating for the period of our proposed embargo or restriction?

Mr. Gillespie: I think it is too early to give an answer to that question, Mr. Speaker.

Hon. Alastair Gillespie (Minister of Industry, Trade and Commerce): Mr. Speaker, I cannot give that undertaking. I have already indicated that a procedure has been adopted for the purpose of processing applications for permits and for determining what the supply situation is I can give the undertaking that the government is most concerned about continuing to have available supplies for our traditional customers and to safeguard their interests.

Mr. Gleave: Mr. Speaker, in view of the fact that the mills which process rapeseed meal have ample supplies on hand and there is no shortage of rapeseed meal, has the minister or the Minister of Agriculture made an accurate survey to ascertain the amount of rapeseed meal on hand and whether it can be substituted for soybean meal?
