Hon. Robert K. Andras (Minister of Manpower and Immigration): The Unemployment Insurance Commission does not maintain individual statistics for (a) Kapuskasing (b) Hearst (c) Smooth Rock Falls. Geographically they are included in the Timmins District Office Statistics.

#### Question No. 3,353-Mr. Coates:

- 1. What is the estimated shortfall between contributions to the UIC fund and the pay-out of benefits that will occur by the end of the present fiscal year based on present projections?

- 3. What was the loss to the fund for the fiscal year 1974-75?

- Hon. Robert K. Andras (Minister of Manpower and Immigration): In so far as the Unemployment Insurance Commission is concerned: 1. It is forecast that at the end of this year, there will be a current year surplus of \$295 million which would have the effect of reducing the cumulative deficit to \$123 million.
- 2. Bill C-69, Amendments to the Unemployment Insurance Act, 1975, is currently before Parliament, and costs for the period October 31, 1975 to March 31, 1976 will be affected by the outcome of that Bill.

In the absence of a Constituency Advisory Group, Departmental officials of the Job Creation Branch regional office in Halifax consulted with local representatives from Information Canada, the Department of Recreation, the Municipal Council, the Social Services Department and the Canada Manpower Centre in the consideration of 85 applications submitted from the constituency of Cumberland-Colchester North. Although the application met the basic Program criteria, other applications in the Amherst area were assessed to be of higher priority in that they more closely met the needs of the community. Consequently, due to lack of funds, the project was not recommended for funding. The final decision, however, rested with the Minister of Manpower and Immigration, who subsequently concurred with the recommendation not to fund the project.
