

## REQUEST FOR CALLING OF GENERAL ELECTION

**Right Hon. Joe Clark (Leader of the Opposition):** The Prime Minister, as is his custom, has quoted selectively from the rule—

**Some hon. Members:** Oh, oh!

**Mr. Clark:**—and conveniently ignored the statement of principle that the question cannot be before two public bodies at the same time. He refuses—

**An hon. Member:** Parliament is supreme.

**Mr. Clark:**—to answer my question. Someone behind him says "Parliament is supreme." Last night in London, when his Minister of Justice was lobbying the British on a matter still before this House, the minister said that the people of Canada are supreme and, if they do not like what the government is doing with its constitutional resolution, then they can throw this government out at the next election.

The Prime Minister knows that his constitutional proposal was not discussed during the last election. He knows he has no mandate for the constitutional proposal he is trying to push through this House of Commons.

**Some hon. Members:** Hear, hear!

**An hon. Member:** Scrape up your courage, Pierre!

**Madam Speaker:** Order, please. This is quite early in the question period for my having to get up to call order constantly.

**Right Hon. P. E. Trudeau (Prime Minister):** Madam Speaker, I did not think the Leader of the Opposition would use a debate on the future of the Constitution of Canada, use this device to prop up his leadership which has been withdrawn from him.

**Some hon. Members:** Oh, oh!

**Some hon. Members:** Call the election!

**Mr. Andre:** Spineless!

**Madam Speaker:** Order.

**Mr. Trudeau:** Madam Speaker, I am glad to respond to that challenge. Let us—

**An hon. Member:** Yes or no!

**Mr. Trudeau:** Let us pass this bill in all stages—

**An hon. Member:** No, no! Let's have it now!

**Mr. Trudeau:** They are afraid to answer my challenge of passing this bill, and then—

**An hon. Member:** You coward.

**An hon. Member:** Bill Davis did it last week.

**Mr. Munro (Hamilton East):** Bill Davis won on it last week!

**Madam Speaker:** Order, please. Will the hon. members please let the Right Hon. Prime Minister finish his answer?

**Mr. Baker (Nepean-Carleton):** I think he is finished. He is finished now!

**Mr. Trudeau:** As to the referral to the rule, Madam Speaker, I read the end of the paragraph: "the question cannot be put before two public bodies at the same time."
