# CANADA LABOUR CODE—PROTECTION OF WOMEN'S RIGHTS

Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, today, pursuant to Standing Order 36, I wish to table a petition which concerns the preventive withdrawal of pregnant women from the workplace.

The Canada Labour Code must observe the principle set forth in the Canadian Charter of Rights and Freedoms, and is thus supposed to protect the rights of women.

The regulations on compensation for pregnant women do not consider all the demands of the workplace.

The option of preventive withdrawal from the workplace for pregnant women is one that is both desirable and necessary for women working outside the home.

Mr. Speaker, I myself signed this petition, with residents of Senneterre and Val d'Or who humbly pray and call upon Parliament to give serious consideration to the shortcomings of the legislation when the Canada Labour Code is reviewed and recognize the need for including

provisions in the Code concerning the preventive withdrawal of pregnant women from the workplace. [English]
