Order in Council P.C. 1957-943, approved July 11, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of Hudson Bay Railway land for the establishment of a building area for the use of civilian operators at Churchill airport.

Order in Council P.C. 1957-983, approved July 23, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of Transcontinental Railway land in the Town of LaTuque, Quebec and authorizing the conveying of the said land to the Corporation of the Town of LaTuque.

Order in Council P.C. 1957-984, approved July 23, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of land in the City of Corner Brook, Newfoundland, and authorizing the conveying of the said land to the City of Corner Brook.

Order in Council P.C. 1957-985, approved July 23, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of land and land covered by water in the County of Queens, Prince Edward Island and transferring the management, charge and direction of the said land from the Minister of Transport to the Minister of Public Works under certain specified conditions.

Order in Council P.C. 1957-986, approved July 23, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of land in the First Range, Township of Mailhot, County of Laviolette, Quebec, and transferring the management, charge and direction of the said land from the Minister of Transport to the Minister of Public Works.

Order in Council P.C. 1957-1171, approved August 27, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of land in the City of Halifax, Nova Scotia, and transferring the administration, management and control of the said land to the National Harbours Board.

Order in Council P.C. 1957-1355, approved October 9, 1957: Withdrawing from entrustment to the Canadian National Railway Company a parcel of land in Lot 28 near the town of Borden, Prince Edward Island and transferring the management, charge and direction of the said land from the Minister of Transport to the Minister of Public Works.
