The benefit of this arrangement can tardly be over-estimated, as all possiblity of loss is avoided, whilst increased banking facilities will be obtained, resulting in a rapid extension of the trade.

- The liabilities of G. R. Fabre, wholesale saddlery hardware, who failed last week, are somewhat larger than was anticipated, totalling \$220,413. Of this amount \$80,042 is direct, \$8,616 privileged, and \$130,664 paper under discount in the People's, Merchants, Hochelaga, Ontario and Jacques Cartier banks, the first-named being interested to the extent of \$75,133, and the latter \$6,740. No statement of assets has been yet completed, but according to balance sheet struck at first of year there was a surplus of \$66,000, reduced from \$100,000 three years ago.

- Joseph Labonté, of Rivière du Loup en haut, has been arrested on a charge of forgery, in having forged the name of one Denis Boutigué dit Bouthillier to an application of insurance, and which he gave to the Ottawa Agricultural Insurance Co., at the same time giving a note in payment of the premium thereon, which was also a forgery. Patterson, laid the charge as above stated, and at the preliminary examination held on Monday, the prosecution fyled a deposition made by the accused, acknowledging that he had signed the name to the application and note. The latter, however, he had paid himself last September before it was discovered as being a forgery. The Ottawa Insurance Co., in taking this prompt action, are determined to stamp out any attempt at fraud on the part of their canvassers in any shape, and it is hoped it will be a lesson to all other insurance canvassers.

-The affairs of Albert Odell, jeweller, of Sherbrooke, are receiving attention at the hands of his creditors. When he commenced business about a year ago he stated he had got the stock, amounting to about \$5,000, from his brother, for which he gave a note of \$3,000, with the understanding that said note was not to be used, nor paid except at his convenience, and used this as an inducement to the trade to grant him credit, which, as a rule, they seemed willing to do. He now calls upon his creditors and wants them to accept 15 cents upon the dollar of their claims, stating that he owes \$4,000 odd and has assets consisting of stock of \$1,600. His creditors naturally suspect a "Nigger in the fence" somewhere, especially as none of the goods recently bought by him appear to be in stock.
