

TOOK 5,000 MILE TRIP IN INJURED SHIP

Captain W. H. Logan, the marine superintendent for the Furness Withy Steamship Company, at Montreal, also the salvage officer and special agent for the Salvage Association, of London, which is a branch of Lloyds, is in the city. He arrived from England where he delivered the Royal Mail steam packet Trent, of 5000 tons when ashore on the Salmadina reef, off the coast of Central America. Captain Logan in conversation with a Standard reporter yesterday said that the steamship Trent went on the reef on the 6th of January. On the 30th of March he with his men reached the wreck on their steamer and set to work pulling her off the reef. The outside bottom of the steamer was practically gone. The tank tops on the inside bottom had not received any great injury. Captain Logan had this temporarily repaired and by the aid of anchors and cables the disabled ship was successfully pulled off into deep water on the 2nd of April, floating only on her tank tops.

BOYS CHARGED WITH ROBBING CHURCH POOR BOXES ADMITTED THEIR CRIME TO POLICE

The preliminary examination of Bartholomew Grogan and William Rogers, the two youthful thieves who are charged with robbing the poor boxes in the Cathedral and St. Peter's and St. John the Baptist churches, also with stealing \$5 from the till in Mrs. McCormack's restaurant on Prince William street, was resumed in the police court yesterday afternoon. Three witnesses were examined and the boys were further reamed. Detective Killen was the first to testify. He told of receiving a message from Bishop Casey on Monday, and immediately went to the Cathedral to view the situation. Altogether seven boxes were tampered with. None were missing, but four were minus locks, which were produced by witness. In the sexton's office witness found bars, spikes, etc., on the floor. None of the implements found are the property of the church. While on the street the next day, witness heard from the conductor that the boxes in St. Peter's church had been robbed, and the thieves arrested.

RAMSEY USED AXE ON MRS. BUSHARA

In the police court yesterday William Carr, George Sudeo and Matthew Korr were each fined \$4 for drunkenness. Wm. Andrew, charged with profane language and violently resisting the police was fined \$4 for the first offence and \$16 or two months in jail for the second. James Ramsey, who is a frequent visitor to the police court for drunkenness appeared to answer to a charge of striking Mrs. Mary Bushara, with an intent to kill. Mrs. Bushara, who is an Assyrian, lives in the upper flat of No. 75 Erith street, and Ramsey, the defendant, lives on the ground floor. Mrs. Bushara testified to the effect that Ramsey had struck her in her own yard without any provocation whatever. Witness also stated that it was only last week that the defendant tried to choke her mother and threatened to kill her. In answer to Ramsey, the witness said she did not see Edward Grey run at defendant with a hammer, or George Bushara beat him with a stick. The woman said she was badly bruised, where she struck with the axe on the second attempt. Tilley Shears, a colored maiden, gave the same evidence as Lottie Horne, who testified that she was beaten by George Bushara and George Grey and he was not guilty of assaulting the woman.

CANDIDATE SHOULD BE ELECTED IN ST. JOHN COUNTY BY-ELECTION

To the Editor of the Standard: Sir,—The Evening Times of Wednesday tells its readers that the Liberals of this county owe nothing to the Hazen administration; that they have reason to distrust it; it has not fulfilled its pledges. In looking over its article I assumed that the Times had undertaken to show, by other than a mere declaration, why the Liberals should take a hand against the Hazen government. But there is no reason vouchsafed; not a single instance of a broken pledge; not even a statement of fact, nor a basis for an argument; merely a thoughtless, ill-conceived, foolish notion of the editor, very flippantly if characteristically expressed. I did not support the Hazen party in the last election, but I am of the opinion that within the few short months it has been in power it has done much good for the province. It was important to our people that they should know the true condition of their finances. There had not been a complete audit of accounts for at least eighteen years, and the public were without any reliable information as to how their business stood. There were suspicious, and for some reason the financial world would not deal with our provincial bonds. The banks were protesting. The true condition of the treasury was not known, and the facts given to the people whose money was involved. It did so, and the people were astounded with the result. We know now just what there was in the suspicious which found expression on every hand; we know now why the bankers had protested against the methods employed by the Hazen government. The methods of the Hazen government met with the approval of the financial world; securities, and the public credit was rehabilitated. We can now meet any emergency which the public services may call upon us to meet. The development of our natural resources, a work retarded in the past by the inability of the old government to assist in it. Important changes in the situation, not about by the Hazen government, but one which should be given public endorsement. An Act Which Was Sorely Needed. We have now an audit act under which it is not possible for members of government to misappropriate the public moneys. Does not this act seem to you as a step in the right direction? We have a modern system of bookkeeping in the place of a system under which dishonesty could be checked. We have the control of our highways placed directly in the control of the people.

FELL OFF DECK OF HOLLAND BENNETT

New York, June 25.—The arrival of Mrs. Lucetta Upham Bennett and Professor William H. Sallman, of Yale on the Berlin of the North German Lloyd line Wednesday night, removed all probability of the death of Mrs. Bennett's husband, Holland Bennett, a young Boston lawyer, by means other than a fall from the deck of the Berlin while the vessel was between Genoa and Naples. The Berlin docked at Hoboken at half-past nine o'clock. Mr. Bennett Thursday, June 10, disappeared in broad daylight and search for him was begun immediately, and it seemed impossible he could have gone overboard without being seen by some one on the ship. This improbability caused the captain of the Berlin to refuse at first to believe that Mr. Bennett had fallen overboard. Then followed such a search as a big steamship does not offer experience at sea. Every part of the big ship which could by any possibility conceal a man was raked for a clue to the missing passenger. All this proved vain and it was not until accepted that Mr. Bennett who was suffering from acute nervousness, had fallen into the sea. It was a pitiful ending of Mrs. Bennett's honeymoon. Her mother, Harry T. Upham, city auditor of Cambridge, Mass., and her brother-in-law, William Bennett, of New York, went down on the customs tug to meet the Berlin. Her mother and brother were on the North German Lloyd pier when the vessel arrived. Professor Sallman, who met the Bennetts in Capri and continued with them, said that in Genoa Mr. Bennett, who had been very nervous and ill, became much worse and went to see a specialist there. His wife was informed that he was suffering from an acute melancholia and was in a dangerous condition. The extended trip planned by the Bennetts had already been cut short because of Mr. Bennett's father. The Berlin left Genoa in the afternoon and just after five in the afternoon Mr. Bennett, much upset, went to Professor Sallman's stateroom door. He asked Professor Sallman to accompany him to the ship's surgeon and the former agreed, but said he could not go for a minute. When Professor Sallman immediately afterwards looked for Mr. Bennett he could not be found. The search that followed proved vain. Holland Bennett was twenty-seven years old, a son of Josiah Quincy Bennett, president of the Cambridge Electric Company, vice-president of the S. S. McClure Company, and was a graduate of Yale, '04 and Harvard Law School. He was suffering from serious operations in the winter of 1907-8 and never recovered from the effects. He was married on May 12 to Miss Upham. Mr. Upham said he and Holland Bennett's parents learned only after the latter's disappearance that Holland had suffered a sudden attack of prostration on the street a few months ago, which rendered him unconscious and which he kept a secret from all but a physician he consulted. Mr. Upham believes his son-in-law was overboard while suffering from a similar attack.

TO PREPARE TAXATION AGREEMENT

Yesterday afternoon the sub-committee of the Treasury Board met at City Hall and discussed the matter of Street Railway taxation. It was finally decided to have the assessors make up the assessment of the Street Railway according to the old agreement with the understanding that the new one is to be substituted for the old as soon as possible. The Recorder in the meantime is to draft the new agreement preparatory to submitting it to the Treasury Board and the St. John Railway Company. Provisions of Agreement. The provisions of the proposed agreement are as have been previously announced. For an assessment on the whole of the real and personal property of the railway there will be substituted a tax for two and one-half per cent on the gross earnings. All present exemptions are to be continued by the company. The St. John Railway Company will leave for Sussex at seven o'clock this morning. The regulars from Fredericton will go through on the Montreal express at noon. The advance parties of the other corps which will train at Sussex, will arrive at camp on Monday. At one time he was a St. John shipbuilder. The aged visitor was delighted with his drive and its scenery, and he was in the beauty of our local breathing places. Mr. Whelpley came to St. John aboard the speedy schooner "T. W. Cooper," which is captained by the Capt.
