Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I rise on a question of privilege, one in which I am sure all members of the house will be happy to concur. It so happens that on July 15, 1870, 99 years ago today, the first four provinces of Canada were joined by the province of Manitoba, the first province to enter confederation after it had been established. This means that today we are entering our one hundredth year as a province of Canada. As members must be aware, plans have been made for appropriate celebrations of this important occasion. Established by a previous government, a commission headed by Mr. Maitland Steinkopf has been working for some time to make plans for the celebration of our centennial as a province. We in Manitoba hope that many thousands of Canadians will visit us during this year, particularly as we approach the historic date of July 15, 1970.

I am sure hon. members will pardon me if I add one footnote, namely, that it is a particular pleasure for me to note that we are entering this historic year with a new provincial government. I am sure all hon. members will want to extend best wishes to our former colleague, who until a few weeks ago was the hon. member for Selkirk, but who today has become Premier Schreyer of Manitoba.
