I am informed what is known as the McCormick Bill purporting to

authorize the construction of a canal and diversion of water from the Great Lakes to the Gulf of Mexico has been referred to a special committee for investigation and report. The committee are meeting to hear evidence on Monday, February eleventh. The Commission considers this diversion of water a serious interference with the power projects administered by the Commission on behalf of the municipalities and the Province of Ontario who are vitally interested and have an investment approximately two hundred and fifty million dollars. I hope you will take the necessary action to properly protect and safeguard all interests concerned and greatly oblige.
