nize Marriages, to return Certificates thereof to the Surrogate of the Island—and to require Clergymen to keep a Record of Baptisms."

And the following Bills for their concurrence:

A Bill intituled "An act for raising a Fund, by an Assessment on Land, for erecting a Government House, and other Public

Buildings within this Island."

And a bill intituled "An act for the more effectual recovery of sums subscribed towards the support of Clergymen and Schoolmasters; and towards erecting and repairing Churches, Chapels, Meeting Houses, and School Houses."

Message from the Council, by Mr. Nantes:

"Mr. Speaker,

"His Majesty's Council request a further conference with the House of Assembly on the subject-matter of the Amendments to the Bill intituled "An act for the Relief of his Majesty's Roman Catholic Subjects,"—and have appointed the same committee to manage the said conference—to meet in the Committee Room instanter.

Ordered, that Mr. Cameron, Mr. Owen. Mr. Brecken, and Mr. Lewellin be a committee to manage the said conference.

Whereupon the Managers went to the conference:

Mr. Cameron reported, that they had been at the Conference, and that the Committee of the Council acquainted them, that his Majesty's Council had consented to withdrawall amendments to which this House had not signified its concurrence, except the fifth amendment, to which they adhere, being an addition to the Oath as follows:-- "And I do hereby disclaim, disavow, "and solemnly abjure any intention to subvert "the present Church Establishment, as "settled by Law within this Realm."

Resolved,-That this House do agree to

the said amendment.

Ordered, that the Bill intituled "An act for the Relief of His Majesty's Roman Catholic Subjects," be re-engrossed, with the amendments agreed to.

Adjourned to 11 o'clock to-morrow.
