Spies Asking Pardon.

BERLIN, Nov. 30.—Two French spies

petition was in vain.

Working Up the Wine Trade.

MADRID, Nov. 30.—The Spanish Govern-
ment has appointed a committee to raise
the United States with a view to encourag-
ing the export of Spanish wines to that
country. The committee will endeavor to
open markets wherever it is possible to do
so. It is charged that native American
wines are adulterated for blending with Cali-
fornia wines.

A Deadly Machine.

BRANZ, Nov. 30.—Here, Fortner, the
