- 2. All those retained were recruited under delegation from the Public Service Commission and all positions in question were advertised.
- 3. The estimated additional cost in the fiscal year 1972-73 is \$644,456.

### NATIONAL DEBT-INTEREST COST PER CAPITA

### Question No. 37-Mr. Mather:

What was the interest cost of the national debt on a per capita basis in (a) 1968 (b) 1971?

Hon. John N. Turner (Minister of Finance): Since the Public Accounts of Canada are based on a fiscal year ending on March 31 of each year, it is not possible to derive the cost of the national debt on a per capita basis in any given calendar year. The gross interest and related costs of the national debt on a per capita basis for the fiscal years ending March 31, 1969, and March 31, 1972, were \$70.64 and \$92.23 respectively. A major portion of these costs arises from the government's role as a financial intermediary extending loans to Crown corporations, agencies and departmental loan programs. These activities generate a return on investments which is recorded as a budgetary receipt. Although not netted out against public debt charges, the return on investments may be considered as an offset to the gross cost of the national debt. The per capita costs of the national debt, net of the return on investments, for the fiscal years ending March 31, 1969, and March 31, 1972, were \$37.46 and \$40.22 respectively.

### NATIONAL REVENUE, CUSTOMS DIVISION— ESTABLISHMENT OF COMPUTER CENTRES
