YOUNG CANADA WORKS PROGRAM—REQUEST FOR FURTHER **GRANTS—MOTION UNDER S.O. 43**

THREATENED WORK STOPPAGES—REOUEST FOR PARLIAMENTARY INVESTIGATION—MOTION UNDER S.O. 43

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, under the provisions of Standing Order 43 I would like to present a motion of urgent and pressing necessity. In view of the increasing tension, as evidenced by the demonstration on Parliament Hill today, in the long drawn-out contract negotiations between the government of Canada and the Canadian Union of Postal Workers which threatens further work stoppages in the Post Office, and the growing demand for action by members of parliament from both sides of the House, including government members, as evidenced by a question directed to the Prime Minister (Mr. Trudeau) by the hon, member for Vancouver-Kingsway (Mrs. Holt) on February 23, I move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Darling):

That the government set up immediately a special committee of parliament to investigate the Post Office to bring in recommendations for solutions and, in particular, to consider the advisability of converting Canada Post to a Crown corporation.

CANADIAN BROADCASTING CORPORATION REQUEST CORPORATION ALLOW CANADIANS TO FORM OWN

JUDGMENTS-MOTION UNDER S.O. 43

That would be a futile search. I therefore move, seconded by the hon. member for Madawaska-Victoria (Mr. Corbin):

That this House, through Mr. Speaker, inform the president of the CBC that the people of Canada are intelligent and sophisticated enough to make their own decisions if the CBC and other news media provide them with the facts, and that he show more respect for the intelligence and judgment of Canadians.
