**SEARCH AND RESCUE****NECESSITY FOR STATIONING AIRCRAFT AND MAINTENANCE CREWS IN NEWFOUNDLAND—MOTION UNDER S.O. 43**

**Mr. George Baker (Gander-Twillingate):** Madam Speaker, I rise on a matter of urgent and pressing necessity. Because of repeated demonstrations of the need to station fixed-wing aircraft in Newfoundland to complement our search and rescue squadron, and because this need was demonstrated again less than 48 hours ago when a stern trawler sank 120 miles north of Newfoundland at 2 a.m. yesterday morning, and since that ship, after losing its steering in high seas, began to swamp and requested search and rescue assistance which was denied, and since the two fixed-wing aircraft which just happened to be at a Newfoundland airport but were from another province were unable to bring pumps to the ship to keep it afloat, because the aircraft maintenance crews are stationed in another province and the aircraft needed maintenance, I move, seconded by the hon. member for St. John's East (Mr. McGrath):

That this House recognize that enough is enough and request the government to station fixed-wing aircraft and maintenance crews in Newfoundland on a permanent basis.

**NUCLEAR ENERGY****URANIUM SHIPMENTS TO SOVIET UNION—MOTION UNDER S.O. 43**
