COPY of a Report of a Committee of the Honorable the Privy Council approved by His Excellency the Governor General in Council, on the 12th June, 1879.

On a memorandum dated 10th June, 1879, from the Hon. the Minister of Railways and Canals, stating that he has had under consideration a communication dated 19th May, 1879, from the Lioutenant-Governor of British Columbia, enclosing a Minute of his Executive Council of the 14th May, 1879, in reference to the reserva-tion of land on the mainland of British Columbia, between Barrard Inlet and Yellow Head Pass

The Minister recommends that the Government of British Columbia be informed that the object of the Order in Council of the 22nd April, 1879, was simply to rescind the Order in Council of the 23rd May, 1878, so as to leave the Government free to adopt whichever route might appear in the public interst the most eligible.

That it is not proposed to release the reservation of land on either route, and it is felt that this will result in no serious inconvenience for the short period which will now elapse before the location of the railway will be finally established.

The Committee submit the above recommendation for Your Excellency's approval.
